INFORMATION PURSUANT TO LAW n° 196/2003

"Protection of persons and other subjects regarding the processing of personal data"

Pursuant to law n° 196/2003, the current law regarding the protection of persons and other subjects regarding the processing of personal data, the EURICSE Foundation must provide you with the following information:

1. Personal data are collected directly at the time of compilation of the following form.
2. The processing of personal data consists in the storing of the data in a data bank and is carried out automatically in a manner which guarantees the security and confidentiality of the data. This processing serves the purposes of the organisation and management of the initiatives promoted by EURICSE.
In this regard, the furnishing of the data on the organisation is necessary lest it be impossible to continue with our relationship.
3. Article 13 of law n° 196/2003 assigns you specific rights. In particular you can obtain from the data holder confirmation of the existence of the data on the organisation, and communication to you of these data. You can ask for the deletion, or the transformation into anonymous form or the blocking of data processed in breach of the law, as well as the updating, correction or integration of the data. You may object, for legitimate reasons, to the processing of your data.
4. The holder of the processing of your data is the EURICSE Foundation in the person of *pro tempore* legal representative.
